Subject: Directive 2014/41/EU on the European Investigation Order
- Information from the Commission on the implementation of the Directive
in view of the transposition deadline

Directive 2014/41/EU of the European Parliament and of the Council regarding the European Investigation Order (EIO) was adopted on 3 April 2014 and published in the *Official Journal* on 1 May 2014 (L 130, p. 1). Article 36(3) reads as follows: "*By 22 May 2017, Member States shall transmit to the Commission the text of the provisions transposing into their national law the obligations imposed on them under this Directive.*"

Member States will find attached a table provided by the Commission services, indicating the Member States and the measures that have been transmitted to the Commission in application of Article 36(3) of the EIO Directive (situation on 15 May 2017). So far, three Member States have notified measures to the Commission: DE, FR, RO.
